

Privacy Policy

Nexedge Group is engaged in providing various financial and ancillary services and in the course of its business and while dealing with Investors, investors and website users may become privy to your personal information including information that is confidential in nature.

For the purpose of this Privacy Policy, wherever the context so requires the term "You" or "User" shall mean any natural or legal person including Online and offline investors and the term "We", "Us", "Our" shall mean Nexedge Group.

We at Nexedge Group respect the privacy of everyone who visits this website and are committed to maintaining the privacy and security of the personal information of all visitors to this Website.

We view the protection of your privacy as a very important principle. We understand clearly that You and Your Personal Information is one of our most important assets. Collection Of Sensitive Personal Data Or Personal Information:

In addition to the personal information and in order to provide the services to You, Nexedge Group may also collect Your Aadhaar, finger – print details and signature solely for completing the account opening procedures and authenticating Your transactions. The act of providing Your Aadhaar is voluntary in nature and We hereby agree and acknowledge that Nexedge Group will collect, use and store such details in compliance with applicable laws and this Privacy Policy. Nexedge Group will continuously endeavour to ensure that Personal Data shall be used in line with all applicable data protection laws including GDPR, where applicable. Your information will be kept secured with restricted access according to the 'need to know' principles.

Nexedge Group or its authorized agents shall not retain or store that information for longer than is required for the purposes except when the information may lawfully be used or is otherwise required under any other law for the time being in force.

The information collected shall be used for the purpose for which it has been collected.

Right to Opt-out:
